**PETITION FOR WRIT OF MANDAMUS AND DECLARATORY JUDGEMENT**

**MOTION FOR EXPEDITED HEARING**

COMES NOW, Petitioner, Robin Mayes, pro se, and files this Motion for Expedited Hearing in the above titled case for the following reasons to wit:

1. Protest period for filing an election appeal in the Supreme Court expires 6-12-2017 and delay of this Petition for Writ of Mandamus and Declaratory Judgement will prevent Petitioner from establishing the required grounds for appeal of the 2017 Election.
2. Petitioner intends to prove that interference with the Election Commission occurred in sufficient magnitude to disqualify at least one candidate that won in the general election. Disqualification of a winning candidate will require either a runoff with new candidates or a new election to fairly remedy the impact thereof.
3. Petitioner's information indicates new evidence in the process of discovery will reinforce his complaint but needs the participation of the Election Commission at a hearing to complete discovery in time to remedy before the August 14<sup>th</sup> inauguration date.
4. A delayed election will result in extra term limit for a winning candidate that is not sworn in to a "full term."


## CONCLUSION


